- **Beneficiary Account Number Format:** BGSE + TRADING CODE
(Example: **BGSEMSLE0929**, where MSLE0929 is the trading code)
- **Beneficiary Name:** BgSE Financials Limited
- **IFSC Code:** UTIB0CCH274

Step 2: Transfer Funds

Transfer the required amount using NEFT / RTGS / IMPS.

Result (Post Successful Transfer)

1. Amount gets credited to **BgSE Financials Limited** account.
2. Back-office entry is **posted automatically**.
3. Your **trading limit is updated instantly**.
